## Certified Recovery Specialist (CRS) Training Series 2024

- Candidates must begin by creating an account at <https://www.pacertboard.org/>
- Once an account is created candidates must apply for the class at <https://www.pacertboard.org/class/recovery-specialist-244>
- The class is currently set to "private" and the **case sensitive** password to access the application is **ARC POWER**
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

\*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
